## Co-President's Message

### Volunteer to Join Board in 2026

Terry and I hope you had a happy holiday, and after one of the busiest falls ever for our League, we hope all are ready to begin work anew in this New Year of 2026. We will need several new Board members to fill open positions as Vice President, Secretary, Treasurer, and Voter Services, so we hope many of you will volunteer for these important jobs to our Nominating Committee chair Mary O'Brien, [mobrien42@verizon.net](mailto:mobrien42@verizon.net) or the other four members of the committee—Glorian Berk, Neil Cohen, Dale Grant or Kathleen Mulcahy—as they prepare the slate to be voted on at our Annual Meeting. Our Board meetings take place on Zoom on the first Wednesday of every month at 4 p.m.

### 250th Anniversary in 2026

2026 is the year when our nation is celebrating the 250th anniversary of the signing of the Declaration of Independence—the semiquincentennial, 1776-2026—when many events throughout the nation are planned, including a Suffolk County 250th Anniversary Passport, to encourage residents to visit landmarks, museums and historic sites that tell the story of Long Island's role in the nation's fight for independence. It includes, of course, the 613-acre William Floyd Estate in Mastic Beach, the former home of Floyd, who was the only signer of the Declaration of Independence from Long Island, and one of only four from NYS.

### New Election Procedures in 2026 Elections

2026 is also the year when the New York State primary election takes place on June 23 (with new voting machines expected to come into use) and when the mid-term Congressional, NYS Governor, State Senate & Assembly, and now town elections, too, all take place on general election day, November 3. As a result of the NYS Legislature's passage of a bill to eliminate odd-year elections for most local offices, we will have an even larger number of candidate debates to hold in the fall of 2026 than the record five we held in the fall of 2025.

### Important Federal and State Victories for LWV

On October 31, a federal court ruled in *League of Women Voters Education Fund v. Trump* to permanently block a provision of his executive order that would require the showing of a passport or similar document proving citizenship when registering to vote, with the court saying that election procedures rest with Congress and the states.

On December 12, Governor Kathy Hochel signed the ERIC (Electronic Registration Information Center) bill into law, for which LWVNYS and 40 local NYS Leagues including ours, sent a special letter urging her to sign. The bill, already adopted by 26 other states, uses data from state voter files, DMV records, the U.S. Postal Service, and the Social Security Administration to help election officials clean up voter rolls by identifying cross-state movers, in-state updates, deceased voters, etc.

Leagues continue to have a lot of important work to do. We need your help and send every best wish to all for the New Year,

Nuestras reuniones de la Junta Directiva se realizan por Zoom el primer miércoles de cada mes a las 4 p. m.

### 250.<sup>o</sup> Aniversario en 2026

2026 es el año en que nuestra nación celebra el 250.<sup>o</sup> aniversario de la firma de la Declaración de Independencia —el semiquinientosenario, 1776-2026—, cuando se planifican muchos eventos en todo el país, incluido el Pasaporte del 250.<sup>o</sup> Aniversario del Condado de Suffolk, para alentar a los residentes a visitar monumentos, museos y sitios históricos que cuentan la historia del papel de Long Island en la lucha de la nación por la independencia. Esto incluye, por supuesto, la finca William Floyd de 613 acres en Mastic Beach, la antigua residencia de Floyd, quien fue el único firmante de la Declaración de Independencia de Long Island y uno de solo cuatro del estado de Nueva York.

### Nuevos procedimientos electorales en las elecciones de 2026

2026 también es el año en que la elección primaria del estado de Nueva York se llevará a cabo el 23 de junio (con la entrada en uso prevista de nuevas máquinas de votación) y cuando las elecciones de medio término

para el Congreso, el gobernador del estado de Nueva York, el Senado y la Asamblea estatales, y ahora también las elecciones municipales, se realizarán todas el día de las elecciones generales, el 3 de noviembre. Como resultado de la aprobación por parte de la Legislatura del estado de Nueva York de un proyecto de ley para eliminar las elecciones en años impares para la mayoría de los cargos locales, tendremos un número aún mayor de debates de candidatos en el otoño de 2026 que el récord de cinco que realizamos en el otoño de 2025.

### Importantes victorias federales y estatales para la LWV

El 31 de octubre, un tribunal federal dictaminó en *League of Women Voters Education Fund v. Trump* bloquear permanentemente una disposición de su orden ejecutiva que habría exigido la presentación de un pasaporte o un documento similar que comprobara la ciudadanía al registrarse para votar, señalando el tribunal que los procedimientos electorales corresponden al Congreso y a los estados. El 12 de diciembre, la gobernadora Kathy Hochul promulgó la ley ERIC (Electronic Registration Information Center), para lo cual LWVNYS y 40 Ligas locales del estado de Nueva York, incluida la nuestra, enviaron una carta especial instándola a firmarla. La ley, ya adoptada por otros 26 estados, utiliza datos de los archivos estatales de votantes, registros del DMV, el Servicio Postal de los Estados Unidos y la Administración del Seguro Social para ayudar a los funcionarios electorales a depurar los padrones electorales mediante la identificación de personas que se mudaron entre estados, actualizaciones dentro del estado, votantes fallecidos, etc.

Las Ligas continúan teniendo mucho trabajo importante por hacer. Necesitamos su ayuda y enviamos nuestros mejores deseos a todos para el Año Nuevo.

Our outstanding Voter Services Committee chair Neil Cohen, who sadly is leaving our Board, thanks all who made this possible—the debate organizers Mary Pellicane, Valerie Levenstein, Ena Pappas and Alicia Sullivan; the moderators Cathy Kenny, Judi Roth,

Estelle Gellman, Terry Wildrick and Jo-Ann Robotti; the timekeepers Eileen Mercer and Mary O'Brien; the shadows Ellen Goldstein, Kathleen Mulcahy and Stephanie Snider; the question vетters Glorian Berk, Susan Wilson, Estelle and Kathleen; and Arlene Hinkemeyer, who did set-up with SEA-TV and LTV, and publicity news releases and flyers.

Fall of 2026 will see an even larger need for candidate debates, as November 2026 will bring elections not only for U.S. Congress, NYS Senate and Assembly, as before, but also local elections, which have been moved by the NYS legislature from odd-numbered to even-numbered years.

# Youth Committee's "Running & Winning" Focuses on Running for School Boards (Continued on next page)

Piggybacking on the Government Committee's forum titled "School Boards, the Training Wheels of Democracy," moderated by Chair Andrea Gabor at LTV Studios on September 18, the Youth Committee also chose that title this year for its "Running & Winning" program at the Water Mill Community House on November 19.

The program focused on how to run for School Boards, since this year for the first time, every school district with a high school in NYS was required to select a student to serve as an ex officio member of its Board, to provide student input.

Nearly 40 students attended R&W this year from seven

East End high schools—East Hampton, Greenport, Hampton Bays, Mattituck-Cutchogue, Sag Harbor's Pierson High, Southampton and Westhampton Beach—including eight of the new student ex officio school board members.

After a welcome and opening remarks by Youth Committee chair Susan Wilson, Co-President Arlene Hinkemeyer introduced the six school board trustees and the eight student board members attending.

Kathleen Mulcahy introduced the three featured speakers—Kathee Burke-Gonzalez, a former Springs School Board President who is now East Hampton Town Supervisor; Brian Mealy, former Mattituck-Cutchogue School Board trustee, now Southold Town Councilman; and Suzanne Mensch, recent Westhampton Beach School Board President. They spoke about why and how they ran for office; the important responsibilities and challenges of a School Board member, such as creating all district policies, hiring a Superintendent of Schools, and presenting a Proposed Budget every year for a May public vote, with a 2% tax cap.

Students then had a chance to ask questions of the






